

Transit visa

To obtain a transit visa the following documents must be submitted to the Consular Section of the Embassy:

1. Completed visa application form; To
fill out visa application form:
 - Visit the website: <http://evisa.mfa.gov.az>
 - Register in “Sign up” page.
 - Fill out the “Application form”.
 - Submit the application form.
 - Print the completed application form received on e-mail.

2. **Valid passport or other travel document (photocopies will not be accepted)** which should have at least one clear page for the visa;

A passport must be valid for no less than three months after the date of your planned departure from Azerbaijan.

Holders of travel documents must submit valid permanent resident card.

3. **Two passport sized photos** of the applicant; Colored photos must be full face.
4. **Travel itinerary;**
5. **Consular fees** is following (important notice regarding the payment, please see page 2):

Single entry (up to 3 days) - \$20 US dollars;

Double entries (up to 3 days) - \$40 US dollars;.

To obtain a visa by mail, the request must include a postage paid return envelope. The Embassy of Azerbaijan does not assume any responsibility for the loss postal delivery. As the Embassy does not keep tracking numbers of your mail, you are advised to keep a record of it in way to track your passport's return to you.

Single entry visa

To obtain a single entry visa for travel to the Republic of Azerbaijan the following documents must be submitted to the Consular Section of the Embassy:

1. **Completed visa application form;**

To fill out visa application form:

- Register in “Sign up” page.
- Fill out the “Application form”.
- Submit the application form.
- Print the completed application form received on e-mail.

2. **Valid passport or other travel document (photocopies will not be accepted)** which should have at least one clear page for the visa;

A passport must be valid for no less than three months after the date of your planned departure from Azerbaijan. Holders of travel documents must submit valid permanent resident card.

3. **Two passport sized photos** of the applicant taken within the last 6 months to reflect the current appearance;

Colored photos must be full face.

4. **The invitation letter;**

- For business and humanitarian visit - the invitation letter from receiving party along with the copy of the charter and state registration certificate of the company/organization;
- For personal visit- the invitation letter from Azerbaijani citizen or foreign citizen currently residing in Azerbaijan along with their Azerbaijani ID (şəxsiyyət vəsiqəsi);
- For leisure – copy of hotel reservation and flight itinerary

5. **Consular fee for the Australian citizens:** 58 US dollars (important notice regarding payment: please see page 2).

To obtain a visa by mail, the request must include a postage paid return envelope. The Embassy of Azerbaijan does not assume any responsibility for the loss postal delivery. As the Embassy does not keep tracking numbers of your mail, you are advised to keep a record of it in way to track your passport's return to you.

Multiple entries visa

To obtain a multiple entries visa (up to 1 year) for travel to the Republic of Azerbaijan the following documents must be submitted to the Consular Section of the Embassy:

An invitation from a receiving party should be sent through Consular Department of the MFA; The instruction from the Consular Department of Ministry of Foreign Affairs regarding the confirmation of the invitation of receiving party should be received by the Embassy. 4. **Consular fee for the Australian citizens:** 350 US dollars (important notice regarding payment: please see page 2)

Important notice regarding payment

Visa fees for the citizens of Australia are:

- **Transit single entry (up to 5 days) - \$20 US dollars (a copy of round trip ticket should be submitted);**
- **Transit double entry (up to 5 days) - \$40 US dollars (a copy of round trip ticket should be submitted);**
- **Single entry (3 to 90 days) - \$58 US dollars;**
- **Multiple entry (up to 1 year) - \$350 US dollars;**

IMPORTANT NOTICE: PAYMENTS ARE MADE ONLINE AND FROM DIFFERENT BANKS ARE NOT ACCEPTED. PLEASE MAKE ALL PAYMENTS FROM COMMONWEALTH BANK'S BRANCHES.
